Website Policy

1. **Purpose for Website:** Best Friends 4-H Club has an educational and informative website at bf4hclub.com. Best Friends 4-H Club leaders and the 4-H Program Coordinators for Michigan State University Extension Office of Berrien County, Michigan, have developed Best Friends 4-H Club website for the purpose of ...
 - A. Explaining and promoting Best Friends 4-H Club Canine Therapy Dog Competition Programs for the Non-Traditional (aka NTR) and Traditional (aka TR) 4-H'ers.
 - B. To assist with keeping 4-H'ers, Leaders and Parents up to date with club activities and 4-H policies.
 - C. To assist with references for canine training.
 - D. To assist with references for 4-H leader's training.
 - E. To assist with references for the types of life challenges and/or disabilities a child may have.
 - F. To assist with registration forms for the year.

2. **Parent/Guardian/Leader Website Agreement:** A parent/guardian and/or leader must sign a Best Friends 4-H Club Website Agreement Form (*found on the Best Friends 4-H Club Yearly Club Enrollment Form*) stating that

"I have read the Best Friends 4-H Club's Website Agreement Policy and do hereby ☐ GIVE CONSENT or ☐ DO NOT GIVE CONSENT to post my own, my child's and/or my canine's audio, video, film, and/or print image on the Best Friends 4-H Club's website located at bf4hclub.com."

3. **Website Give Consent:** By checking the "Give Consent" and signing the Best Friends 4-H Club Website Agreement Form ...
 - A. It is understood that under no circumstances will my child's or my own name and/or contact information identify the image being used on the Best Friends 4-H Club's website.
 - B. It is understood that that only my canine's call name and breed identification will identify my canine's audio, video, film and/or print image on the Best Friends 4-H Club's website.
 - C. It is understood that the audio, video, film and/or print image chosen is done so with the intention of education and the promotion of the

 - D. It is understood that the audio, video, film and/or print image may edited, duplicated, distributed, reproduced, broadcasted, and/or reformatted in any form and manner without payment of feed in perpetuity.
4. **Website Do Not Give Consent:** By checking the "Do Not Give Consent" and signing the Best Friends 4-H Club Website Agreement Form it is understood that the child's, parent, leader, and/or the named canine's audio, video, film and/or print image may not be used on the Best Friends 4-H Club's website.
5. **Agreement Validation:** It is understood that with the parent/guardian and/or leader signature of consent or non-consent, the agreement shall be valid until Best Friends 4-H Club's webmaster, coordinator, and/or Michigan State University Extension Office decide to update, change, and/or delete the website. Or the parent/guardian and/or leader has a change of mind and states so in writing.
